



For more information regarding housing payment deadlines and amounts owed, please refer to the Housing License Agreement, the Housing website, or the Housing Fee Schedule handout for the Spring 2011 semester.

Payments for Housing can be made in three ways:

1. **Mail** a check or money order payable to CSUCI along with the corresponding payment coupon to the University Cash Services' office.
2. **In person** take cash or check payable to CSUCI to the University Cash Services' office located in Sage Hall with the corresponding payment coupon.
3. **Log in** to your "myCI" account and pay with a credit card (excludes VISA), or an e-check via the web. Please be advised that coupons are not required to be submitted for web payments, but can be used as a personal record that a payment has been made. **New CI Students:** Online payments via credit card or an e-check are available after you receive your University log in at Island View Orientation.

Payment options include payment In Full, or Installment Payment Plan.

1. **In Full** payment plan is based on housing accommodations. Use Coupons 1 and 2.
2. **Installment Payment Plan (IPP)** includes a non-refundable \$33 processing fee. The fee is calculated into the payments. **Note:** If the Licensee does not declare a payment preference on their signed license agreement, the University will assume Licensee is using the Installment Payment Plan (IPP) option and automatically apply the \$33 IPP fee to the account.
